Debut of ICANN's Functional Reporting

- This month marks the debut of "ICANN's functional reporting" for community review. The functional reports will be available on the ICANN dashboard. The purpose of this new reporting is to support ICANN's core principles of accountability and transparency. The reports are in response to community requests to better understand the manner in which ICANN's spending is prioritized. The new reporting more closely aligns with the way the community considers the activities of ICANN (e.g., new gTLD, compliance, and security expenses in contrast with the traditional reporting of expenses by personnel, travel, etc.). This is an evolving process improvement. We welcome suggestions to further improve on this for the future. See the public comments http://www.icann.org/en/public-comment/
- The functional reporting categories were determined based upon the strategic plan, operating plan, community suggestions, and Board Finance Committee discussions. As part of the implementation of this initiative, an announcement of the reporting is to be posted along with for community comments. Ultimately, this type of reporting will help facilitate the setting of priorities for ICANN's budgets as well as help ensure that the budgets are spent efficiently.

The following table includes the YTD actual and YTD budget #'s as well as annual expected and FY09 budget #'s, and the respective variances.

Explanation of key variances in FY09 Expenses: ICANN expenses in FY09 are below budget as some initiatives and new hires set forth in the Operating Plan are ramping up slower than anticipated. For example:

- Security initiatives include strengthening of ICANN corporate security and continuity programs, enhancing the security and stability of IANA and L-root operations, and conducting security and resiliency capacity building programs with the TLD community are expected to expand the second half of the year. We are working to refine the cross-functional analysis of security, stability and resiliency programs as part of the FY 10 operational planning/budget build.
- Travel expenses are less than budget through the mid-year point. Much of this
 is due to the scheduling of two out of three meetings in the second half of the
 year.
- New gTLD communications, RSTEP, Registrar Data Escrow, organizational reviews, technical research for administrative improvements, financial system replacement, regional meetings, and other costly items in the FY09 budget have been delayed or postponed due to community and other environmental requests.

Broaden Participation	Broaden participation includes awareness of ICANN's processes to all stakeholders, global engagement, regional liaisons, the fellowship program, monitoring international activities, extend outreach program, and expanding the translation program.			
Ombudsman	Support ombudsman efforts including investigation costs and outreach activities			
Board Support	Support Board efforts including Board Members travel, training, and membership.			
Nom Com	Support for NomCom meetings and travel support for candidates.			
Lroot	Root operation equipment, bandwidth, and license fees.			
New gTLD	Complete new gTLD implementation including complete the applicant guidebook, set up application processing (e.g., TAS), and launch worldwide communication program.
