RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Mr. Wesson:

Please be advised that as of 21 May 2012, Alice's Registry, Inc. ("Alice's Registry") is in breach of its Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 17 October 2010 ("RAA"). This breach results from:

- Alice's Registry's failure to respond to ICANN's 2011 Whois Data Reminder Policy ("WDRP") audit pursuant to Section 3.14 of the RAA.

In addition, Alice's Registry has been deemed non-compliant in the following area:

- Not clearly displaying on its website a link to ICANN's Registrant Rights and Responsibilities webpage, as required by Section 3.15 of the RAA.

Please refer to the attachment below for details regarding these breaches and ICANN's attempts to contact Alice's Registry. ICANN requests that Alice's Registry cure the breaches by 11 June 2012, 15 working days from the date of this letter, by taking the following actions:

1. Complete the 2011 WDRP audit questionnaire pursuant to Section 3.14;
2. Provide all requested documents to demonstrate compliance with the WDRP;

ATTACHMENT

Failure to Respond to Registrar Audit

Section 3.14 of the RAA requires Alice's Registry to timely provide documents and information concerning a contractual compliance audit to demonstrate compliance with the terms of the RAA upon no less than (15) days notice by ICANN.

ICANN sent Alice's Registry the 2011 WDRP compliance audit request on 25 January 2012. All registrars were required to respond by 15 February 2012. ICANN sent Alice's Registry multiple compliance notices requesting that Alice's Registry complete the 2011 WDRP audit questionnaire (see the chronology below). As of the date of this letter, Alice's Registry has not contacted ICANN in response to these requests and has not complied with the requests.

Alice's Registry's repeated failure to complete the 2011 WDRP audit questionnaire constitutes a breach of Section 3.14 of the RAA.

Failure to Display a Link to ICANN's Registrant Rights and Responsibilities Webpage

Section 3.15 of the RAA requires Alice's Registry to provide a link to ICANN's Registrant Rights and Responsibilities webpage on its website.

ICANN sent Alice's Registry two notices advising that Alice's Registry was required to provide a link to ICANN's Registrant Rights and Responsibilities webpage on its website by 27 July 2011. As of the date of this letter, Alice's Registry has not provided a link to ICANN's Registrant Rights and Responsibilities webpage on its website.
