RE: NOTICE OF TERMINATION OF REGISTRAR ACCREDITATION AGREEMENT

Dear Mr. Red:

Be advised that the Internet Corporation for Assigned Names and Numbers (ICANN) Registrar Accreditation Agreement (RAA) with Desto! Inc. (Desto) is terminated. As explained in greater detail below, this termination is based on Desto's failure to cure the breach set forth in ICANN's letter dated 30 March 2009. This termination shall be effective fifteen calendar days from the date of this letter on 23 October 2009.

Desto is further advised that the logo license appendix to the above mentioned RAA is revoked. ICANN demands that Desto remove all ICANN trademarks that have been licensed to Desto immediately from Desto's website and business materials under the terms of that appendix.

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. Desto currently owes ICANN \$5,427.49 in past due accreditation fees. Notices regarding Desto's past due accreditation fees, including detailed customer statements, were transmitted to Desto several times.

On 30 March 2009, ICANN sent Desto a notice of breach of RAA based on Desto's failure to pay past due accreditation fees in the amount of \$713.75. Desto failed to cure this breach in the time period allowed by the RAA.

Based on Desto's failure to cure the breach of Section 3.9, and in accordance with Section 5.3 of the RAA, ICANN hereby gives Desto notice that Desto's accreditation will terminate on 23 October 2009. For your reference, a copy of ICANN's 30 March 2009 notice of breach and a current financial statement are enclosed.

Please note that termination of Desto's RAA does not relieve Desto of the obligation to pay delinquent accreditation fees, which should be paid immediately. ICANN reserves the right to pursue all means available to collect these fees.

ICANN's records indicate that Desto is not currently managing any domain names. If, however, Desto recently registered domain names, ICANN will follow its De-Accredited Registrar Transition Procedure

We encourage you to read the Procedure in its entirety. Consistent with the Procedure, we are requesting that Desto designate a bulk transfer recipient immediately if it recently registered domain names. Please contact ICANN's Registrar Liaison Manager, Mike Zupke mike.zupke@icann.org, to designate a bulk transfer recipient. Kindly note, however, that

your designation of a bulk transfer recipient does not prejudice ICANN's right to the Registration Data Escrow data and other rights under the RAA, as well as ICANN's right to transfer names to a registrar of our choosing selected pursuant to the Procedure. It is ICANN's goal to protect registrants from unnecessary harm and we anticipate the full cooperation of Desto if it necessary to implement the Procedure.
