<p>As a required step in the GNSO Policy Development Process (PDP), ICANN Staff requested input on the Preliminary Issue Report on Translation and Transliteration of Contact Information [PDF, 649 KB]. Following the request for an Issue Report by the GNSO Council on 17 October 2012, ICANN Staff published the Preliminary Issue Report on Translation and Transliteration of Contact Information for public comment. <p>MN agrees with the recommendations in the Preliminary Issue Report, particularly with the deferral of a PDP until the work of the Expert Working Group on the purpose of domain name registration data is complete. He notes, "...any outcome of a PDP at this juncture could conflict with recommendations from another PDP, thus rendering the entire process even more confusing than it already is."</p>			

The SSAC notes that it has provided advice relating to the issues identified in the Preliminary Issue Report. In addition, the SSAC emphasized the importance of waiting for the work of the Expert Working Group to be complete. The SSAC agreed with ICANN staff that the work of the Expert Working Group could have bearing on the issue of translation and transliteration of contact information and that a PDP on this issue should be initiated, but deferred.
