.CLUB Registry Agreement, Specification 5, Section 2:\\r\\\n\\r\\\nTwo-character labels. All two-character ASCII labels shall be withheld from registration or allocated to Registry Operator at the second level within the TLD. Such labels may not be activated in the DNS, and may not be released for registration to any person or entity other than Registry Operator, provided that such two-character label strings may be released to the extent that Registry Operator reaches agreement with the related government and country-code manager of the string as specified in the ISO 3166-1 alpha-2 standard. The Registry Operator may also propose the release of these reservations based on its implementation of measures to avoid confusion with the corresponding country codes, subject to approval by ICANN. Upon conclusion of Registry Operator's designation as operator of the registry for the TLD, all such labels that remain withheld from registration or allocated to Registry Operator shall be transferred as specified by ICANN. Registry Operator may self-allocate and renew such names without use of an ICANN accredited registrar, which will not be considered Transactions for purposes of Section 6.1 of the Agreement.\r\n

We do not believe a contract amendment is necessary. We request ICANN's approval to release two character labels that do not appear on the ISO 3166-1 alpha-2, pursuant to the RA Specification 5, Section 2: "The Registry Operator may also propose the release of these reservations based on its implementation of measures to avoid confusion with the corresponding country codes, subject to approval by ICANN". Releasing only the two character domains that do not correspond to an existing country code avoids confusion with country code addresses, and should therefore be approved by ICANN.\text{

#### **Benefits of Service**

Describe the benefits of the Proposed Service:

Some of the benefits of allowing two character SLD labels are 1) increased consumer choice, 2) equitable regulatory treatment from ICANN for new gTLD operators and legacy TLD operators, and 3) increased competition between new gTLDs and Legacy gTLDs. \rangle Vn

### Competition

Do you believe your proposed new Registry Service would have any positive or negative effects on competition? If so, please explain.:

Approving our proposal will have a positive effect on competition. The current regulatory environment creates an artificial barrier to entry into the two character SLD marketplace in favor of the legacy TLDs, which are currently permitted to register two character SLDs (.e.g., .com, .net, .asia). Removing this barrier will allow more market participants to enter and would therefore enhance competition.\text{\text{Vn}}
