In order to meet the needs of all affected parties we seek a limited amendment which allows in the circumstances of Specification 13 compliance the Registry Operator to release the domain where the IGO concerned has been consulted and the IGO has no objection to the release of the domain. We would propose the following substitute clause.\r\n6. Intergovernmental Organizations. As instructed from time to time by ICANN, Registry Operator will implement the protections mechanism determined by the ICANN Board of Directors relating to the protection of identifiers for Intergovernmental Organizations. list of reserved names for this Section is available http://www.icann.org/en/resources/registries/reserved. Additional names (including their IDN variants) may be added to the list upon ten (10) calendar days notice from ICANN to Registry Operator. Any such protected identifiers for Intergovernmental Organizations may not be activated in the DNS, and may not be released for registration to any person or entity other than Registry Operator except where the Registry Operator has signed Specification 13 and has consulted the Intergovernmental Organisation affected and the affected organisation has no objections. This will ensure that Bentley Motors Limited will be able to meet the needs of local markets.
