1. Do you believe the proposed service would have any positive or negative effects on competition? If so, please explain.

We believe that the service will have a positive effect on competition. With respect to competition between registries, Charleston Road Registry d/b/a Google Registry (

2. How would you define the markets in which the proposed service would compete?

The proposed service will compete in all markets in which Google Registry TLDs are sold.

3. What companies/entities provide services or products that are similar in substance or effect to the proposed service?

Other registries (e.g. Afilias, Verisign, fTLD Registry, Top Level Design, and more) already offer registry lock as a service in their TLDs. By offering registry lock as a service, Google Registry does not prevent other registries from offering the service in their TLDs.

4. In view of your status as a Registry Operator, would the introduction of the proposed service potentially impair the ability of other companies/entities that provide similar products or services to compete?



No, we do not believe that offering registry lock in Google Registry's TLDs will impair the ability of other companies that provide the same service to compete. Offering registry lock in Google Registry's TLDs has no effect on the ability of other registries to do the same.

5. Do you propose to work with a vendor or contractor to provide the proposed service? If so, what is the name of the vendor/contractor, and describe the nature of the services the vendor/contractor would provide.

Google Registry outsources all of its registry services to Google LLC and will do the same in offering registry lock, and will work with its registrar channel to implement the service. No other vendors will be used.

6. Have you communicated with any of the entities whose products or services might be affected by the introduction of the proposed service? If so, please describe the communications.

Google Registry has discussed its plans to offer registry lock with multiple registry partners, including corporate registrars who are the primary users of the service. All registrars with whom the proposed service was discussed were strongly supportive of the proposal to introduce registry lock to Google Registry TLDs.
