

Dear Registry contact,

Please be aware that the following updates on the <u>Monitoring System API</u> (MoSAPI) and the <u>Registration Reporting Interfaces</u> (RRI):

- 1) Support for obtaining the **List of SLAM probe nodes** is now available in RRI and the Operational Test Environment for RRI (RRI-OTE). The interface is described in section 5 of the RRI specification (https://datatracker.ietf.org/doc/html/draft-lozano-icann-registry-interfaces).
- 2) Support for the **management of maintenance window notifications** is now available in RRI and RRI-OTE. The interfaces are described in section 4 of the RRI specification (https://datatracker.ietf.org/doc/html/draft-lozano-icann-registry-interfaces).
- 3) Support for the **management of maintenance window notifications** is now available in NSP through a friendly web interface. Information about the new functionality can be found in the Naming Services portal for Registry Operators section of the ICANN website (https://www.icann.org/resources/pages/nsp-registry-operators-2020-08-04-en).
- 4) Support for the .test TLD in MoSAPI production environment is available as of now to allow Registries to test their MoSAPI implementations.
- 5) An OTE for MoSAPI will be released in the first semester of 2022 to allow Registries to test their MoSAPI implementations.

Please be aware that the following updates on the Monitoring System API (MoSAPI) and the Registration Reporting Interfaces (RRI) are expected to be released on 1 August 2022. The following functionality will be retired:

- Support for the List of SLAM probe nodes in MoSAPI. The interfaces to be retired are described in section 7 of the MoSAPI specification (https://www.icann.org/en/system/files/files/mosapi-specification-29jun20-en.pdf).
- Support for the **management of maintenance window notifications in MoSAPI.**The interfaces to be retired are described in section 6 of the MoSAPI specification (https://www.icann.org/en/system/files/files/mosapi-specification-29jun20-en.pdf).
- The email address <u>tld-maintenance-notification@icann.org</u> previously used to sendmaintenance window notifications by email.
- Support for obtaining the List of ICANN-accredited Registrars' RDAP Base URLs in MoSAPI. The interface to be retired is described in section 11 of the MoSAPI specification (https://www.icann.org/en/system/files/files/mosapi-specification-29jun20-en.pdf).

Note: the **List of ICANN-accredited Registrars' RDAP Base URLs** will only be available in IANA (https://www.iana.org/assignments/registrar-ids/registrar-ids.xhtml).
