#### The Global Name Registry, Limited Monthly Operator Report March 2002

As required by the Registry Agreement between the Internet Corporation for Assigned Names and Numbers ("ICANN") and The Global Name Registry, Limited ("Global Name Registry") (the "Registry Agreement," Section 3.15), this report provides an overview of Global Name Registry activity through the end of the reporting month. The information is primarily presented in table and chart format with explanations as deemed necessary. To the extent that an entry is "N/A," this signifies a metric that cannot be tracked until Live SRS. Information is provided in the order as set forth in Appendix T of the Registry Agreement.

Note: The SLA permits two 12-hour windows per year to perform major upgrades.
