Re: Request for Bulk Access to Whois Data

Dear Mr. Levy,

I write to reiterate our request that Register.com, Inc. provide third-party bulk access to its WHOIS data to Verio Inc. pursuant to Section II.F.6 of Register.com's Registrar Accreditation Agreement with ICANN. Specifically, Verio requests that Register.com make a complete electronic copy of its WHOIS data available at least one time per week for download by Verio, as required by Section II.F.6.a of Register.com's Registrar Accreditation Agreement.

Consistent with Section II.F.6.b of such Registrar Accreditation Agreement, Verio will agree "to pay an annual fee, not to exceed US \$10,000, for such bulk access to the data." I note that in connection with the ongoing dispute between our two companies, we had an opportunity to cursorily review a bulk access agreement that you proffered to another party. In such agreement we noted a provision requiring that a \$10,000,000 bond be posted in order for such party to have access to your WHOIS data. We, like such other party, will not agree to any such "hidden fee" provisions as your Registrar Accreditation Agreement quite clearly states that \$10,000 is the maximum you can charge for access to the data.

Verio will further agree to use the data for lawful purposes and will not "use the data to allow, enable, or otherwise support the transmission of mass unsolicited, commercial advertising or solicitations via e-mail (spam)." As you know, ICANN has recently indicated that (i) the foregoing use restriction applies only to electronic mail and does not prohibit use of the WHOIS data in connection with other lawful marketing methods and (ii) any provision further restricting use of your WHOIS data would contravene your Registrar Accreditation Agreement.



We would be happy to provide you with a draft bulk license agreement that we would be prepared to sign, or to consider a draft that you prepare. Regardless of who prepares the first draft, we hope any such draft will contain provisions consistent with your Registrar Accreditation Agreement and other terms and conditions that are fair and consistent with industry standards for comparable transactions. In other words, to be blunt, we hope you will not attempt to use your leverage as the data provider and tender a draft inconsistent with the qualities set forth in the preceding sentence and then be intransigent in negotiations towards a final agreement. We will consider any such attempt to be another effort to prevent third-party access to your WHOIS data and, thus, another violation of your Registrar Accreditation Agreement.
