### 1. Accredited Registrar Status –

Table 1 displays the current number and status of the ICANN accredited registrars. The registrars are grouped into three categories:

*Operational registrars:* Those who have authorized access into the Sponsor’s registry system for processing domain name registrations.

*Registrars in the Ramp-up Period:* Those who have received a password to access the dotCoop operational test and evaluation (OT&E) environment. The OT&E environment is provided to allow registrars to develop and test their systems with the dotCoop LLC registry system.

*Registrars in the Pre-Ramp-up Period:* Those who have been sent information by dotCoop, but have not yet executed the Registry Confidentiality Agreement and/or have not yet submitted a completed Registrar Information Sheet.

There was some disruption to DNS resolution of nic.coop addresses for users using the new BIND DNS server (released to combat Verisign's SiteFinder) - this lasted for three days while the problem was diagnosed, and nic.coop delegation was set up in the .coop zone. The problem was first reported on 22/09/03 and fixed by 24/09/03
