Re: Notice of Intent to Terminate the Registry Agreement for .mobily

Dear Kevin Wilson and Anwar Ahmed,

This letter constitutes written notice of ICANN org's intent to terminate the .mobily Registry Agreement.

Specifically, ICANN org is invoking certain provisions set forth in the previously agreed-upon confidential terms between ICANN org and GreenTech Consultancy Company W.L.L., as the Registry Operator for the .mobily generic top-level domain (gTLD). ICANN org intends to terminate the .mobily Registry Agreement by initiating the Registry Agreement termination process effective immediately.

On 1 December 2016, GreenTech Consultancy Company W.L.L. was issued a Notice of Breach by ICANN Contractual Compliance. Subsequently, and pursuant to Section 4.3(a) of the Registry Agreement, ICANN org initiated termination proceedings by serving a Notice of Mediation under Section 5.1 of the Registry Agreement (see updates on ICANN's Notices of Breach, Suspension, Termination and Non-Renewal page here). Resolution of the mediation resulted, in part, in GreenTech Consultancy Company W.L.L. agreeing to certain confidential terms.

Pursuant to those terms, and effective immediately, ICANN org is issuing its <u>Determination</u> to not transition operation of the .mobily gTLD as a result of this involuntary Registry Agreement termination and is instructing IANA to revoke .mobily from the root zone. Upon confirmation of the completion of the IANA change request, ICANN org will terminate the .mobily Registry Agreement.

You should be aware of the following related to the termination of this Registry Agreement:

- Both the <u>mobily Registry Agreement webpage</u> and the <u>Registry Agreement Termination Information Page</u> will be updated to reflect termination-related notices and activities.
- On the effective date of the termination, GreenTech Consultancy Company W.L.L.'s access to the .mobily TLD in the Naming Services portal, the system of record, will be deactivated.
