RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Zdenek Kubik,

Please be advised that as of 16 March 2018, Hebei Guoji Maoyi (Shanghai) LTD dba HebeiDomains.com ("HebeiDomains.com") is in breach of its 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 20 November 2013 ("RAA"). This breach results from:

- 1. HebeiDomains.com's failure to complete and deliver to ICANN a Compliance Certificate within twenty (20) days following the end of the 2017 calendar year certifying compliance with the terms and conditions of the RAA, as required by Section 3.15 of the RAA; and
- 2. HebeiDomains.com's failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

Please refer to the attachment for details regarding this breach.

In addition, HebeiDomains.com has been deemed noncompliant in the following areas:

- HebeiDomains.com's failure to provide and maintain accurate and current information as specified in the Registrar Information Specification ("RIS"), as required by Section 3.17 of the RAA; and
- 2. HebeiDomains.com's failure to display the correct ICANN logo on HebeiDomains.com's website, as required by the Logo License Specification of the RAA.

Additional Concerns

The contact information for HebeiDomains.com is out of date.



ICANN requests that HebeiDomains.com cure these breaches by 6 April 2018, 21 days from the date of this letter, by taking the following actions:

- After curing all breach items identified in this notice, provide a certificate executed by the
 president, chief executive officer, chief financial officer or chief operating officer (or their
 equivalents) of HebeiDomains.com certifying compliance with the terms and conditions
 of the RAA ("compliance certificate");
- 2. Provide ICANN with a completed RIS form, including accurate and current information, the required supporting documentation and the location of any applicable information published on HebeiDomains.com's website, as required by Section 3.17 of the RAA;
- Display the correct ICANN logo on HebeiDomains.com's website in accordance with the Logo License Specification of the RAA, or remove the ICANN logo from HebeiDomains.com's website;
- 4. Provide ICANN with the corrective and preventative action(s) that HebeiDomains.com will take, with implementation date(s), to ensure the following:
 - a. timely payment of fees to ICANN;
 - b. timely and complete response to ICANN Contractual Compliance matters; and
 - c. timely updates to HebeiDomains.com's contact information with ICANN; and
- 5. Pay all past and currently due accreditation fees.

If HebeiDomains.com fails to timely cure the breaches and provide the information requested by 6 April 2018, ICANN may commence the RAA termination process.

ATTACHMENT

Failure to submit to ICANN annual compliance certificate

Section 3.15 of the RAA requires registrars to complete and deliver to ICANN within twenty (20) days following the end of each calendar year, in a form specified by ICANN, a certificate executed by the president, chief executive officer, chief financial officer or chief operating officer (or their equivalents) of the registrar certifying compliance with the terms and conditions of the RAA. HebeiDomains.com's failure to complete and deliver the compliance certificate for 2017 is a breach of Section 3.15 of the RAA.

Failure to pay accreditation fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. HebeiDomains.com owes ICANN past due accreditation fees, in breach of Section 3.9 of the RAA.

Failure to provide and maintain required information

Section 3.17 of the RAA requires registrars to maintain and provide to ICANN the information specified in the RIS. HebeiDomains.com's failure to provide to ICANN and maintain accurate and current information as specified in the RIS is a breach of Section 3.17 of the RAA.

Failure to display correct ICANN-Accredited Registrar logo

The Logo License Specification of the RAA requires registrars, if displaying the ICANN-Accredited Registrar logo, to use the logo displayed in the specification. HebeiDomains.com's use of an unapproved logo is a breach of the Logo License Specification of the RAA.
