Dear James Archer,

Please be advised that as of 24 October 2018, SaveMoreNames.com Inc. ("SaveMoreNames.com") is in breach of its 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 6 July 2015 ("RAA"). This breach results from:

1. SaveMoreNames.com's failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

Please refer to the attachment for details regarding this breach.

In addition, SaveMoreNames.com has been deemed noncompliant in the following area:

1. SaveMoreNames.com's failure to publish its Registrar Information Specification ("RIS") correspondence address on SaveMoreNames.com's website, as required by Section 3.17 and Section 7 of the RIS of the RAA.

Additional Concerns

The officers' name and position published on SaveMoreNames.com's website are inconsistent with the information provided in SaveMoreNames.com's RIS.

Additionally, the number of second level domain names (SLDs) being reported as registered by SaveMoreNames.com is not consistent with the number of SLDs contained in SaveMoreNames.com's escrow deposits.


ICANN requests that SaveMoreNames.com cure these breaches by 14 November 2018, 21 days from the date of this letter, by taking the following actions:

1. Publish on SaveMoreNames.com's website the correspondence address of SaveMoreNames.com as specified in the RIS or update SaveMoreNames.com's RIS form to reflect the correspondence address published on SaveMoreNames.com's website;
2. Confirm whether the full name and position of the officers displayed on SaveMoreNames.com's website are applicable to SaveMoreNames.com and if so, update SaveMoreNames.com's RIS form to reflect the information displayed on SaveMoreNames.com's website;
3. Confirm SaveMoreNames.com's compliance with the data escrow requirements of Section 3.6 of the RAA and provide explanation to address the inconsistent number of SLDs noted above;
4. Provide ICANN with corrective and preventative action(s), including implementation date(s), to ensure that SaveMoreNames.com will:
 - a. timely and fully respond to ICANN Contractual Compliance matters; and
 - b. timely make payment of its ICANN fees; and
5. Pay all past and currently due accreditation fees.

If SaveMoreNames.com fails to timely cure the breaches and provide the information requested by 14 November 2018, ICANN may commence the RAA termination process.

ATTACHMENT

Failure to pay accreditation fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. SaveMoreNames.com owes ICANN past due accreditation fees, in breach of Section 3.9 of the RAA. SaveMoreNames.com additionally owes currently due accreditation fees, due 14 November 2018.

Failure to publish registrar's correspondence address on registrar's website

Section 3.17 of the RAA requires registrars to maintain and provide to ICANN the information specified in the RIS. In addition, registrars must publish on each website through which it provides or offers registrar services, the information specified in the RIS as requiring publication. SaveMoreNames.com's failure to publish its RIS correspondence address on SaveMoreNames.com's website is a breach of Section 3.17 of the RAA and Section 7 of the RIS.
