Call to Order

Duane Wessels called the teleconference to order at 19:00 UTC.

Welcome to Geoff Huston

Duane Wessels welcomed Geoff Huston as the new SSAC appointee to the RZERC.

Agenda Review

There were no amendments to the agenda for this meeting.

Administration

Draft Minutes from 6 November

Duane called for a vote on the draft minutes from the previous teleconference. There were no objections to the minutes and the minutes were approved.

 ACTION ITEM: Staff to publish approved 6 November 2019 minutes on RZERC's website.

Formally conclude RZERC discussion on if the RZERC will be responding to the current Public Comment on IANA's Proposal for Future Root Zone KSK Rollovers

Duane formally reviewed the past discussions from 6 November 2019 and on the RZERC mailing list regarding whether or not the RZERC should comment on the ongoing Public Comment for IANA's Proposal for Future Root Zone KSK Rollovers. The RZERC decided to not make a comment.

RZERC appointment terms

RZERC discussed the member appointment term lengths as determined by the appointing organizations. The RZERC debated whether there was any benefit to returning to the appointing organizations to align term start and end dates to the same dates to ease the logistics of the RZERC Chair selection process. RZERC members proposed amending the operational procedures to provide the flexibility needed in RZERC Chair term length with regard to membership term length as opposed to requesting appointing organizations to align their term calendars.

Ongoing Chair election proceeding

Duane reminded everyone of the ongoing Chair selection process. The nomination period opened on 17 January 2020 and closes on 11 February 2020.

Scheduling placeholder recurring meeting times

Duane proposed resuming a regular schedule of RZERC meetings in 2020 instead of meeting on an ad-hoc basis. Duane reminded RZERC members of an ongoing Doodle poll to select the time and day of the week for a monthly meeting.

Potential Work Items

Signing root-servers.net

The RZERC discussed the possibility of taking on this topic as a formal work item and providing input. Geoff Huston voiced support for taking this item on.

 ACTION ITEM: RZERC to discuss the signing of root-servers.net as potential work item on the mailing list to come to consensus about whether it should be a formal RZERC work item.

ZONEMD Internet Draft

The RZERC discussed the possibility of contributing to Duane's developing internet draft on a message digest for zones, which would add a new record type to the root zone. Several members voiced agreement for RZERC taking on this topic. During this discussion, Jim Reid recalled a previous scoping exercise RZERC conducted on potential work topics that would fall in or out of scope for RZERC. The timing of RZERC taking on this work item is still to be determined.

• ACTION ITEM: Staff to distribute the results of the previous topic scoping exercise to the RZERC members.

RSSAC updating its History of the RSS document

The RZERC discussed a potential work item that stemmed from a discussion within the RSSAC. The RSSAC is updating its history of the root server system document, RSSAC023, and in those discussions determined there were some important historical events related to the contents of the root zone, which were out of scope for RSSAC023. The RSSAC proposed the history of the root zone topics as a possible work item for the RZERC. The RZERC determined this work was not within its scope and it would not be taking up this work item.
